CALL TO ORDER AND ROLL CALL:

The meeting was called to order by Mr. Mick Degn, AMSAC Chairman, at 10:32a.m.

WELCOME & UPDATE & LEGISLATIVE ISSUES:

GOHS Director Alberto Gutier advises AMSAC Council that there are no current legislative bills proposed at this time pertaining to motorcycle issues. Mr. Gutier provides a brief overview of fiscal impacts of any proposed legislative bills; in addition to advising AMSAC Council that this legislative session will be short this year.

BUDGET UPDATE:

GOHS Director Alberto Gutier provides AMSAC Council with SFY 2014 Motorcycle Safety Budget hand-out, which outlines the current budget for the AMSAC Council.

Motion to approve budget, motion seconded, and AMSAC budget approved.

STOCK ITEMS INVENTORY:

GOHS Director Alberto Gutier discusses the success of the newly implemented tracking system of AMSAC inventory and provides an overview of current AMSAC inventory and materials. The current inventory and materials are sufficient for the current requests forms being received by GOHS.

Mr. Gutier advises AMSAC Council that the GOHS Safety Days at the Arizona State Fair was a success and thanked the AMSAC Board Members for attending.

ADVERTISING - RADIO AND SOCIAL MEDIA:

GOHS Director Alberto Gutier discusses media advertisement. Motorcycle safety commercials focus on vehicle driver's watching out for motorcycle riders and sharing the road with motorcycles. Director Gutier confirms with AMSAC Council that advertisements will be done this November and December, as well as during Arizona Motorcycle Week in the months of March or April.

AMSAC Council and Director Gutier discuss additional advertising and media strategies to gain motorcycle safety awareness throughout the State of Arizona.

MOTORCYCLE TRAINING:

Mr. Mick Degn, Chairman advices AMSAC Council that the Arizona Motorcycle Strategic Plan will address the following: 1) Alcohol/DUI's, 2) Prescription Drugs, and Motorcycle Training. Mr. Degn emphasizes how critical the need for Motorcycle Training is for the State of Arizona.

Motorcycle Safety Training became a primary subject during today's AMSAC Meeting. GOHS Director Alberto Gutier suggests that an AMSAC Council Meeting be held to address the subject regarding Motorcycle Safety Training. In addition, Mr. Gutier wants to address concerns of strengthening the motorcycle training and licensing for motors with ADOT. An AMSAC Meeting will be held on **Tuesday**, **December 10**, **2013 at 10:30am**; and the only subject to be placed on this agenda will be Motorcycle Safety Training.

Mr. Gutier believes that this meeting will bring partners together state-wide in a joint effort to create change in Motorcycle Training within the State of Arizona.
