#### **I. Call to Order and Roll Call**

The meeting was called to order by Alberto Gutier at 10:00 A.M. Roll was taken and a quorum was declared present with five Council Members present.

#### **II. Minutes of the January 25, 2017 Meeting**

#### **III. DUI Abatement Funds & Grant Updates**

Alberto Gutier discussed with the council the present funding situation within the DUI Abatement Council.

#### **IV. Grant Agreement Considerations**

1. Buckeye Police Department – Vicki Hill made the motion to approve \$20,000.00 for Buckeye Police Department's DUI Enforcement Overtime funding request, Linda Gray seconded, and all others in favor.
2. Pima County Sheriff's Department – Don Engler made the motion to approve \$75,000.00 for Pima County Sheriff's Department's DUI Enforcement Overtime funding request, Linda Gray seconded, and all others in favor.

3. Yuma County Sheriff's Office – Vicki Hill made the motion to approve \$30,000.00 for Yuma County Sheriff's Office DUI Enforcement Overtime funding request, Linda Gray seconded, and all others in favor.
4. Yuma County Sheriff's Office – Vicki Hill made the motion to approve \$8,400.00 for Yuma County Sheriff's Office sixteen (16) PBT's funding request, Linda Gray seconded, and all others in favor.
5. Yuma County Sheriff's Office – Alberto Gutier explained to the DUI Abatement Council members present that the DUI Abatement Council has traditionally not funded enforcement vehicles. Director Gutier informed the Council that he will speak to Sheriff Wilmot about applying for a DUI enforcement vehicle through GOHS funding.
